D 7.1	<p>To consider the request of Shri Lyndon Cardoso for award of Sports Merit Marks.</p> <p>The Principal of Chowgule College has forwarded a request of Shri Lyndon Cardoso, a student of Chowgule College of Arts & Science, Margao who answered his T.Y.B.Sc. Semester VI in the subject of Geology in April 2017, for award of Sports Merit Marks. It has been informed that Shri Lyndon Cardoso is a physically challenged student.</p> <p>Shri Lyndon Cardoso has participated in the Senior National Futsal Championship - 2016 organised by Rajasthan Futsal Association, held from 26th to 28th December, 2016 at Sawai Mansingh Indoor Stadium, Jaipur.</p> <p>As per Ordinance OA – 5.16 Sports Merit Marks are given to those who participate in the sports events approved by the Sports Council of Goa University, National Sports Federations having recognition of the Ministry of Youth Affairs and Sports/ Indian Olympic Association/ Association of Indian Universities.</p> <p>As Futsal is not in the list of games/disciplines that are eligible for availing of Sports Merit Marks as per Sports Authority of Goa letter dated 27/4/2017, which is placed as Annexure I (refer page no 1), the claim of Shri Lyndon Cardoso for Sports Merit Marks could not be certified. Moreover, Futsal does not feature as a recognized game in the list of events organized by Association of Indian Universities for the academic year 2016-17.</p> <p>As Futsal is not considered for award of Sports Merit Marks as a Policy by the Sports Authority of Goa, the University does not consider claims of students who participate in any of the Futsal Events, irrespective of the category they belong to.</p> <p>The College Directors of Physical Education and Sports within the University system, including the student community are aware of the Sports Events that are eligible for Sports Merit Marks as per the Goa University Ordinance and the Sports Policy of the Government of Goa.</p> <p style="text-align: center;">Standing Committee of the Academic Council may kindly deliberate and decide.</p> <p style="text-align: right;">(Back to Index)</p>
