- 2. The first floor has i) two class rooms to accommodate 30 and 50 students ii) Computer lab with 5 PCs and printing facility with internet connection iii) Library place is available. The first floor will be utilized for the Community College programmes.
- The ground floor has i) one class room to accommodate 20 students ii) one lab. used for Higher Secondary iii) Principal room iv) Office room v
 Library with one table vi) Staff room for six Faculty.
- 4. The other facilities include i) two wells ii) shed net iii) two poly houses for vegetable and floriculture of 500 sq.mts. each iv) 2 toilets for Boys and girls v)o ne changing room vi) Potting shed vii) Store room vii) LCD
- The Society has two acres of land attached to the house on which the house stands. Land of
 6.5 hectares is available with the Society at Savoi Verem in the vicinity.
- 6. MOU is signed with ICAR for Faculty and other facilities.

(ii) Essential Conditions to be fulfilled before the program starts:

- 1. Required faculty (qualified) and additional lab equipments/Instruments (Microscope, Dryer, Glass ware, etc) to be recruited/procured.
- 2. The books as prescribed by the syllabus which are not available may be purchased.
- 3. The Society to make budgetary provisions for the programme and for financial position as per SC-1.
- 4. The ownership of the house and land shall be with the Society.
- 5. The Society to submit the compliance report to the University two weeks before the start of the programme.

(iii) Overall recommendations:

AIC recommends starting of Advance Diploma in Agriculture for the academic year 2016-17 under Community College Ordinance OA-21 with an intake of 30 students subject to approval of syllabus by the Academic Council.

iv) Suggestions of the AIC:

- 1. Addl. Lab space shall be created for the second year.
- 2. Committee under Vishaka Judgment may be constituted.
- 3. Common room for boys and girls to be identified and allocated.
