The statement of marks and other certificates, required to be produced by the candidates must have been signed by the Registrar of the University or by the Secretary to the Examination Board concerned. Certificates from the Principals or the Head of the Institutions through which the candidates had appeared for the respective examination cannot be accepted as valid.

***Fee for Provisional Statement of Eligibility**

The fee prescribed for the provisional statement of eligibility are as follows:

1. Student migrating from other University/Board	Rs. 580/-
2. NRI and ICCR sponsored students	Rs. 580/-
3. Foreign Students	Rs. 3450/-
4. Foreign Students one time admission fee	Rs. 34500/-

Blank application forms for Provisional Statement of Eligibility are available with the minutes University Office. If the application is sent by the post, the fee-should be sent along with it minutes by means of Bank Drafts drawn in favor of the Registrar, Goa University, Sub Post Office, minutes Goa University, Taleigao Plateau, Goa 403 206 payable at State Bank of India, Goa minutes University Branch. Fees for the Provisional Statement of Eligibility are accepted between minutes 10:00 a.m. to 1:00 p.m. and 2:30 p.m. to 3:30 p.m.

Important Instruction to Candidates

Application for the provisional statement of eligibility should be accompanied with the necessary certificates in original and a photocopy of each and the prescribed fee for the provisional statement of eligibility.

A provisional statement of eligibility will be issued to the students at his/her own risk if he/she is found *prima facie* eligible for admission and on condition that he/she submits to the Registrar's office through the Head/Principal of the Institution/college joined by him/her in this college/University, the necessary certificates in original together with a Xerox copy of each for confirmation of his/her eligibility before the close of the academic term in which he/she is provisionally admitted in this University.

The provisional statement of eligibility issued of the purpose of seeking admission to this University in a particular year will not be valid for the purpose of seeking admission in the following years.

The fee paid, for the provisional statements of eligibility will not be returned if a provisional statement of eligibility is issued to the applicant. In case no such provisional statement of eligibility is issued by the university for any reason, one half of the said fee will be refunded.

Admission to the university departments and/or affiliated colleges of this university are made by the Heads of respective Departments and/or the Principals of the affiliated colleges concerned. The University does not undertake to arrange admissions or accept any responsibility for admission either to a University Department or an affiliated college.

The provisional statement of eligibility does not assure the holder of seat in this University. If only declares students eligible for admission to the course of study in this University.

A student seeking admission to C phis University has to approach the Principal of the college which he wishes to join in the matter of his admission and for other relevant information relating to tuitions fees, hostel accommodation, courses of study etc.

The University does not recognize foreign examination on a regular basis, but application of persons desirous of seeking admission to this University on the basis or qualification obtained in

foreign countries are considered for admission to this University on merits of each individual case. For this purpose passing Certificates, transcripts of records and copy of the syllabus containing the details of the courses of studies pursued in the various subjects at the examination passed by the applicant's (duly countersigned by high Commissioner of India in the country or the officer authorized by him) and the standard of passing laid down at the examination should be forwarded to this office well in advance. In case the certificates or transcripts are in a language, other than English, and English translation of the same, duly certified by a competent authority, should be sent.

The University does not have any bursaries or scholarships which can be offered to foreign students.

It is important for a student coming to this University from another country to note that he should not come unless he has a definite offer of a admission and is also assure of all other facilities such as hostel accommodation etc. which may need.

A student from another University or Board of Secondary or Intermediate Education or any statutory Examining Body seeking admission to this University is required to apply to the Registrar for a statement of eligibility in the form prescribed by the University.
