Abstract The programme is driven by debates undertaken by Portuguese recent historiography which offer new perspectives of analysis of the Portuguese Overseas Expansion. Sessions will discuss how, besides the crown and state, individuals and self-organized networks implemented overseas expansion, operating within and outside the system, while contributing to the building of an "informal empire". Autochthone people, women, adventurers and common people will be considered as part of the process of empire building, which was also a globalisation process, and taken as essential to the outcome of Portuguese colonization in the 1500-1800 period.
