NOTIFICATION

1. Selected candidates who cleared the qualifying examinations will have to submit for verification their documents such as marksheets i.e.

Date: 20/06/2019

- Original marksheet of Semester I to V and online print of Semester VI results
- Valid caste certificate in case of SC/ST Category candidates
- OBC Non Creamy Layer certificate in case of OBC candidates
- Valid disability certificate in case of PD candidates

to the respective University Schools/ Departments / affiliated colleges.

- 2. The Last date for verification of documents and payment of fee is 24-06-2019 by 5.00 pm, failing which the seat shall be forfeited.
- 3. Selected candidates under Round I & Round II who have not cleared all the qualifying semesters of a degree are to be offered provisional admission, and such candidates are required to pay Rs. 5000/-. The concerned University departments/School may inform through email the Academic PG section about such candidates so as to release their payment link.
 - Candidates selected at Colleges are required to pay seat confirmation fees of Rs. 5,000/- at the respective college.
 - These candidates will pay their balance fees after the revaluation results, if they have passed the qualifying examinations.
- 4. If such a candidate fails to clear the backlog of the qualifying examination, s/he shall be ineligible to continue the Programme, and the seat shall be forfeited.
 - However, the Rs. 5000/- fees will be refunded.
- 5. Heads of Departments/ Deans of Schools/ Principals of affiliated Colleges are requested to admit additional seats equal to such provisionally admitted candidates (candidates who have not cleared qualifying examination). These seats are to be treated as supernumerary seats.

Counselling Round - III

- 1. Counselling Round III will be held on 27-06-2019 from 10:30 AM onwards for the following programmes:
 - Master of Science in Chemistry
 - Master of Commerce
 - Master of Arts in Hindi
 - Master of Science in Mathematics
 - Master of Science in Microbiology
 - Master of Arts in Konkani
 - Master of Arts in Psychology
 - Master of Arts in Marathi
 - Master of Arts in Economics

- 2. Vacancies arising under the reserved category due to transfer/withdrawal to be offered to the aspiring candidates of the same reserved category. If no reserved category candidates are available, then these seats are to be opened for the General Category at the end of the counselling session.
- 3. All vacant seats of Minority Colleges to be offered to the unreserved category in line with Judgement of the High Court of Bombay and the Supreme Court's Directives) at the counselling to be held on 27-06-2019.
- 4. Spot admissions will be held on 27-06-2019 from 10:30 AM onward at respective Departments/Schools/ affiliated colleges to fill up the vacant seats if any, in all the other Programmes.
- 5. Other University category candidates who are selected for PG admissions but are awaiting their graduation results are to be given time till 30.9.2019 to submit their original VI semester/years mark sheets and are required to pass/qualify all the semesters/years. An Undertaking to be taken from the candidates stating that the admission granted is provisional and the same will be withdrawn if the candidate does not provide proof of qualification/eligibility by 30.9.2019.
