FORMATION OF GOA UNIVERSITY STUDENT'S COUNCIL (GUSC) 2019-20 NOTIFICATION

No. GU/DSW/GUSC/Election/2019-20/439

It is hereby notified, for the information of all concerned, that the Goa University Student's Council for the Academic Year 2019-20, has to be constituted, as per the details set out under amended Schedule SSA-7, as notified, vide Goa University Notification No. 2/562/2018-Legal/Amend-Stat Vol.IX/1874, dated 27.08.2018.

The Students' Council of Goa University shall consist of one representative, designated, as University Faculty Representative (U.F.R), from each Faculty of the Colleges/ University Teaching Department, elected by an Electoral College, consisting of University Class Representatives (U.C.R.), of each class of the affiliated College/ Institution/ University Teaching Departments, as the case may be. The Electoral Roll of a Faculty, in a College/Institution, shall consist of all the UCRs of that Faculty, in the College/Institution, who shall elect one amongst themselves, as UFR, to represent the respective Faculty in the College/Institution, in the University Students' Council. For the purpose of the Statute/Schedule, regulating the formation/functions & procedure of Students' Council, the "Class" means, a body of students, undergoing a course of instruction, leading to a University Semester Examination, in a Faculty.

The Professional Colleges will elect such number of UCRs, corresponding to years of the Courses. In any case, each Professional College will elect only one UFR, as per SSA-7.

Further details regarding the procedure for formation of Students Council of Goa University, is available, for necessary information and compliance of all concerned, in the Amended Schedule SSA-7, as referred to above.

Special attention is invited, of contesting candidates, to the provisions of SSA-7(xii) pertaining to the Code of Conduct, which includes, among other requirements, the timely submission of complete and self-certified audited accounts of the election expenditure, incurred; bio-data, including the details of his/her Membership of various Associations / Organizations. More specifically, the clause (i), wherein certain provisions of the Indian Panel Code, 1860 (Section 153A and Chapter IXA – Offences Relating to Election), shall be made applicable to the elections of Goa University Students' Council.

As per the requirement, stipulated under SSA-(xii)(d), the maximum permitted expenditure, per candidate, at each stage of contest, shall be Rs. 6000/- (Rupees Six Thousand Only).

The Elections shall be conducted, strictly as per the following Schedule, by utilizing the prescribed Forms/Nomination forms, etc., and as per the procedure laid down, along with the prescribed in the relevant Status/Schedule. The relevant Schedule SSA-7, along with the prescribed forms, from 'A' to 'G', is being forwarded, to the respective Colleges/recognized Institutions, with this Notification, and is also displayed on the Goa University website (www.unigoa.ac.in). The Principals of the Affiliated Colleges/ recognized Institutions, are required, to make suitable arrangements, for notifying the same and to conduct the elections, as per the notified time and schedule, in their respective Institutions, and to communicate the results, accordingly.

The Nomination Papers along with the mandatory Enclosures, as per the requirement for contesting election to the Executive Committee of Goa University Students' Council, shall be submitted, to the Office of the Director of Students' Welfare, during office hours, at DSW office, situated on 1st floor, in the Arts and Humanities Faculty, Block-B, Goa University, as above.

As per SSA-7(x)(a), the Principals of the Colleges/Heads of the Institutions/Director of Students' Welfare, or their Nominees, shall prepare separate lists of voters, for each "Class" and the same, shall be notified and displayed, on the Notice Board. The cut-off date for the Eligible Voters Roll, shall be all those students, enrolled and admitted, up until 15th July, 2019.

For the purpose of Election of UCRs and UFRs, the respective Principals of the Colleges/Head of the Institutions/Director of Students' Welfare, or his Nominees, shall be the Returning Officer. Similarly, as per SSA-7 (iv) (k), the Names of the UCRs/UFRs, duly elected, shall be communicated, by the Principal/Head of the Institution, latest by Friday, 09th August, 2019, till 4.00 pm, either by E-mail: dsw@unigoa.ac.in, or by Hand Delivery, to the Office of the Director of

Students' Welfare, 1st Floor, Arts Faculty Block-B, Goa University, in Forms 'F' and 'G', respectively.

Following Schedule for submission of related Documents shall be complied with, by all concerned.

- 1. Complete and Self-Certified Audited Accounts of the Election Expenditure, incurred by candidates, to be submitted, to the Director Students' Welfare Office, as per the following Schedule.
 - a) For U.C.R.s also elected as UFRs: by/before Friday, 09th August, 2019, till 4:00pm.
 - b) For Executive Committee: by/before 19th August, 2019, till 4.00pm.
- 2. Bio-data of Candidate, including details of his/her Membership of various Associations/Organizations to be submitted to the concerned Election Officer by the contesting candidates, along with the appropriate Nomination Paper.

No person shall be nominated unless he/she signifies his/her consent of the nomination paper. It is also not open to an elector to either propose or second his/her own candidature. A nomination paper which does not comply with all the requirements as mentioned above shall be rejected.
- 3. If the total strength of the electoral College is three or less than three in a College/Institution, the nomination paper shall be valid if it is duly signed by the candidate. (In such cases the requirement that the candidature should be duly proposed and seconded by the two signatories
