2. The Estimated cost of work is Rs.1,00,360.00 ( Excluding G S T)
3. The Quotation must be accompany E.M.D of **Rs.2007/-** In form of D.D drawn in favour of the Registrar, Goa University.
4. The EMD as above should be enclosed in separate cover and attached to the cover containing quotations
5. The time allowed for executing the work will be 45 days and shall be reckoned from 15<sup>th</sup> day of issue of the work order.
6. The rates quoted should be valid for 150 days for acceptance.
7. The intending bidder must read the Terms & condition of work as per PWD form 6 & 7. He should only submit his bid if he considers himself eligible and if he is in possession of all the documents required.
8. Bidders shall enclose self attested copies of Registration certificate up to Class V or above (Buildings) Goa state PWD, pan card copy and G.S.T Registration certificate with their quotation.
9. The University shall deduct 10% from the gross amount of work done towards Security deposit and the same shall be retained for a period of 12 months in terms of clause 17 of contract (CPWD FROM 7).
10. The Rates Quoted shall be excluding G.S.T. The applicable G.S.T @ 12 % shall be paid on the total amount of work done.
