## Terms of Reference:

1. To Co-ordinate with the affiliated Colleges and institutions to curb the menace of ragging.

- 2. To call for reports from the Heads of the Educational Institutions in regard to the Activities of the Anti-Ragging Committee, Anti-Ragging Squad, Monitoring Cell at the level of the Institutions as the case may be, the compliance with instruction on conducting orientation programmes, counseling sessions, the incidents of ragging, the problem faced by the Wardens or other officials.
- 3. To keep abreast of the decision of the District Level Anti-Ragging Committee.
- 4. To review the efforts made by the institutions to publicize anti-ragging measures, soliciting of undertaking from parents and students for each academic year to abstain from ragging activities or willingness to be penalized for violations.
- 5. To function as the prime mover for initiating action on the part of the appropriate authorities of the Goa University for amending its Statues or Ordinance or Bye-Laws as the case may be and to facilitate the implementation of Anti- Ragging measures at the level of the Institutions.
- 6. To send the State Level Monitoring Cell the status reports periodically and at such frequency that it may laydown.

The Directorate of Students Welfare will extend the required logistics for the smooth functioning of the Cell.

The tenure of the Monitoring Cell shall be for a period of two years from the date of issue of this order.
