CIRCULAR

In accordance with the Special Ordinance OS-1 relating to the conduct of Examinations during the Covid-19 pandemic and in partial modification to Circular No.GU/Exam/55/2021/142 dated 19/11/2021 regarding Offline Examinations and in continuation to Circular No. GU/Exam-PG/2021/91 dated 10/12/2021, all the Examinations (Even and Odd Semesters) for the 5 Year BA.LL.B and 3 Year LL.B Programmes offered in the Affiliated Colleges of Law commencing from 10th January 2022, **except the Final Year Examinations** (Even and Odd Semesters), shall be conducted in **ONLINE** mode, as per the following guidelines:

1. Pursuant to Goa Government directives all pending ISAs shall be conducted in Online Mode. The Semester End Examinations shall be conducted from 10 January 2022 onwards.
2. The duration of the Semester End Examination and the maximum marks allotted for each Course shall be as per the relevant Ordinances.
3. For the Online Examinations, the question paper shall be made available to the students through a variety of platforms. The students shall be given 30 minutes to download the Question Paper and 30 minutes to upload the Answer Paper. Students shall write down the answers and then scan/photograph, upload and submit the hard copy of the answer sheets as instructed by the College. All typed answer sheets shall not be assessed.
4. The **Final Year Examinations (Even and Odd Semesters)** shall be conducted in **OFFLINE/ PHYSICAL MODE** as per above mentioned Circular.
5. The Final Year Semester End Examinations shall be conducted following all SOPS for Covid – 19 Prevention including social distancing, sanitization of classrooms and using all other necessary precautions (facial masks, sanitizers etc.) shall be adopted as per Covid-19 prevention norms.

Principals of Affiliated Colleges of Law are requested to take note of the same and bring the contents of the Circular to the notice of all concerned.
