These rights can be exercised only by the owner of copyright or by any other person who is duly licensed in this regard by the owner under the ambit of the Copyright Law are:

- In case of literary, dramatic, or musical works, the right to:
  - reproduce the copyrighted work;
  - Prepare derivative work based upon the copyrighted work;
  - Distribute copies of copyrighted work to the public or communicate the work to the public;
  - Perform the copyrighted work publicly;
  - Display the copyrighted work publicly;
  - To translate or adapt the work;
  - To make cinematograph film or sound recording
