Admission: The admission to MBA (Financial Services) is based on CMAT/ATMA followed by the Group Discussion and Personal Interview Round (GDPI)

How to Apply: Candidate needs to fill the application form with all required details and upload required documents online on GUMS Portal available at the University Website. An application fees of Rs.1,000/- (Rupees One thousand only) for General Category candidates, Rs.500/- (Rupees Five Hundred only) for reserved category candidates of Goa and Differently abled candidates are exempted from the payment of application fees. **Last date of receipt of applications is 8th August 2022.** Incomplete applications shall not be considered for selection. Candidates who are shortlisted will be called for the Group Discussion and Personal Interview.
