NOTIFICATION

It is hereby notified, for the information of all concerned, that the Goa University Student's Council for the Academic Year 2023-24, has to be constituted, as per the details set out under amended Schedule SSA-7, as notified, vide Goa University Notifications No. 2/698/2022-Legal(vol.XIII)/694 dated 12/10/2022 and No.2/698/2022-Legal(Vol.XIII)/915 dated 20/12/2022.

The students' Council of Goa University shall consist of one representative, designated, as University Faculty Representative (U.F.R)/ University School Representative (U.S.R), from each Faculty of the Colleges/University School, elected by an Electoral College, consisting of University Class Representatives (U.C.R), of each class of the affiliated College/Institution/ University School, as the case may be (see Annexure I). The Electoral Roll of a Faculty/ School, in a College/Institution/ University, shall consist of all the UCRs of that Faculty/ School, in the College/Institution/ University, who shall elect one amongst themselves, as UFR/ USR, to represent the respective Faculty/ School in the College/Institution/ University, in the University Students' Council. For the purpose of the Statue/Schedule, regulating the formation/functions & procedure of Students' Council the "class" means, a body of students, undergoing a course of instruction, leading to a University Semester Examination, in a Faculty/ School.

The Professional Colleges will elect number of UCRs, corresponding to years of the Courses. In any case, each Professional College will elect only one UFR, as per SSA-7.

Research Students will vote in the discipline/Programme/School to which they belong. Students of BBA, BCA, and such other courses shall vote alongwith the particular faculty which is available in the college.

Further details regarding the procedure for formation of Students Council of Goa University, is available, for necessary information and compliance of all concerned, in the Amended Schedule SSA-7, as referred to above.

Special attention is invited, of contesting candidates, to the provisions of SSA-7(xi) pertaining to the Code of Conduct, which includes, among other requirements, the timely submission of complete and self- certified audited accounts of the election expenditure, bio-data, including the details of his/her Membership of various Associations / Organizations and Undertaking. More specifically, the clause(i), wherein certain provisions of the Indian Penal Code,1860 (Section 153A and Chapter IXA – "Offences Relating to Election"), shall be made applicable to the elections of Goa University Students' Council.

The age limit of the candidate to contest the election shall be as stipulated below:

- a. Under graduate shall have completed 17 years and not more than 22 years of age as on 20th June, 2023 (Should be born on or before 19th June, 2001)
- b. Students of Professional Colleges (Under-Graduate and Post-Graduate) shall have completed 17 years and not more than 26 years of age (Should be born on or before 19th June 1997)

- c. Post Graduate shall not be more than 25 years of age as on 20th June, 2023 (Should be born on or before 19th June, 1998)
- d. Research students shall not be more than 28 years of age as on 20th June, 2023 (Should be born on or before 19th June, 1995)

No student falling in any of the following categories shall be eligible to contest elections or be nominated for any of the elections:

- a. The student who has backlog of any of the courses of earlier Examinations including internal, external and departmental/School examinations of the respective degree.

OR

- b. Who has been admitted to the class from which he/she is contesting by getting the benefit of ATKT

OR

- c. A student who is repeater in a class from which he/she is contesting the elections.

OR

- d. A Student who has past criminal record.

The Candidates must be regular, full-time students of the College/University and should not be distance/proximate education student. That is to say that all eligible candidates must be enrolled in a full time course, the course duration being at least one year.

As per the requirement, stipulated under SSA-(xi)(d), the maximum permitted expenditure, per candidate, at each stage of contest, shall be Rs. 6000/- (Rupees Six Thousand Only).

The election shall be conducted, strictly as per the **following Schedule**, by utilizing the prescribed Forms/Nomination forms, and as per the procedure laid down in this notification. The relevant Schedule SSA-7, along with the prescribed forms, from 'A' to 'G' is being forwarded, to the respective College/recognized Institutions/ Schools, with the Notification, and is also displayed on the Goa University website(www.uni.goa.ac.in). The Principals of the Affiliated Colleges/ Deans from recognized Institutions/ Schools, are required, to make suitable, arrangements, for notifying the same and to conduct the elections, as per the notified time and schedule, in their respective Institutions, and to communicate the results, accordingly.

Similarly, as per SSA-7 (iv) (l), the Names of the UCRs/UFRs, duly elected, shall be communicated, by the Principals/Head of the Institution, latest by 10/08/2023 by 01:00 p.m., either by **E-mail: guscsw@unigoa.ac.in**, or by **Hand Delivery**, to the **Office of the Director of Students’ Welfare, Directorate Building, Block -D, Goa University, in Forms ‘F’ and ‘G’, respectively. Forms submitted elsewhere on the University Campus shall not be considered.**

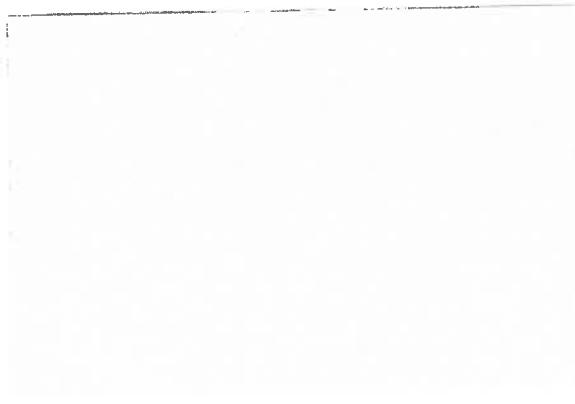
