CIRCULAR

Applications are invited from eligible Under Graduate, Post Graduate, Post Graduate Diploma Students enrolled in various Schools of the University Campus for Award of Merit Scholarship, Free Studentship and Student Aid Fund for the academic year 2023-24.

The eligibility criteria for Merit Scholarship, Free Studentship and Student Aid Fund are as under:

MERIT SCHOLARSHIP

1. Candidate at qualifying examination should have secured at least 60% of aggregate marks in respect of Arts, Commerce and Management Studies and at least 65% of the aggregate marks in Science Stream

FREE STUDENTSHIP

- 1. The applicant should belong to an income group not exceeding **Rs. 3,00,000/- per annum** for the Financial Year 2022-23.
- 2. The candidate should have secured at least 45% of aggregate marks in Arts, Commerce and Management Studies and 50% of the aggregate marks in Science subject at the last qualifying examination with no backlog.
- 3. Applicant should be a resident of Goa for 15 years.

STUDENT AID FUND

- 1. The applicant should belong to the income group not exceeding Rs.**1,50,000/- per annum** for the Financial Year 2022-23.
- 2. The candidate should not have any backlog in his/her qualifying examination.
- 3. Applicant should be resident of Goa for 15 years.

The students are required to submit compulsorily the necessary documents along with their form for various scholarships as follows:

MERIT SCHOLARSHIP

a) Self attested mark sheet copies of both semesters (odd & even) of qualifying examination for the Academic Year **2022-23**. In case the

- programmes having only 1 semester may submit the self-attested marksheet of semester I for the Academic year **2022-23**.
- b) A clear copy of the first page of the applicant's Bank passbook/ Cancelled Cheque/ Bank Mandate form which is duly signed by the Bank Official.
- c) A clear copy of fee receipt.

FREE STUDENTSHIP

- a) Self attested mark sheet copies of both semesters (odd & even) of qualifying examination for the Academic Year **2022-23**. In case the programmes having only 1 semester may submit the self-attested marksheet of semester I for the Academic year **2022-23**.
- b) Family income Certificate of the Financial Year i.e. **2022-23** which should be less than or equal to Rs. 3,00,000/-.
- c) A clear copy of the first page of the applicant's Bank passbook/ Cancelled Cheque/ Bank Mandate form which is duly signed by the Bank Official.
- d) A clear copy of the Ration Card.
- e) A clear copy of the Residence Certificate.
- f) A clear copy of the fee receipt.

STUDENT AID FUND

- a) Self attested mark sheet copies of both semesters (odd & even) of qualifying examination for the Academic Year **2022-23**. In case the programmes having only 1 semester may submit the self-attested marksheet of semester I for the Academic year **2022-23**.
- b) Family income Certificate of the Financial Year i.e. **2022-23** which should be less than or equal to Rs. 1,50,000/-.
- c) A clear copy of applicant's Bank passbook/ Cancelled Cheque/ Bank Mandate form, duly signed by the Bank Official.
- d) A clear copy of Ration Card.
- e) A clear copy of Residence Certificate.
- f) A clear copy of fee receipt.

In view of the recent Bank merger, the IFSC Codes of some Banks have changed. Students are requested to confirm the same before submission.

Students who are pursuing self-financed programmes and those students who were not enrolled for any course or have taken a drop in studies for the academic year 2022-23 are not eligible to apply for the Merit Scholarship/ Free Studentship/ Student Aid Fund.

Those students availing the benefits under the Goa University Scholarships shall not be eligible to avail similar benefits under any other Schemes/ Scholarships. The students would however is permitted to exercise their choice of the schemes/ Scholarships to avail similar benefits.

Students are free to apply for Merit Scholarship, Free Studentship & Student Aid Fund, but shall be eligible for the award of only one Scholarship. A single form should be used even if the student is applying for more than one scholarship.

Candidates should note that the documents such as Bank details, Mark sheets, Income Certificate, Residence Certificate, Fee Receipt and Ration Card should be correct/valid, else the application is liable to be rejected.

All the students desirous of applying for the Merit Scholarship, Free Studentship and Student Aid Fund are requested to fill the requisite form which are available in the Schools and submit the duly filled in form complete in all respects to the concerned School.

The last date for students to submit application to their respective Schools is **31/01/2024**.

All the Deans/Vice-Deans of Schools are requested to verify the application forms and forward the same along with the application summary duly filled in the provided Excel sheet format to the Directorate Office on or before <u>05/02/2024</u>.
