NOTIFICATION

GU/Acad-Admissions/GU-CLAT II/2025-26/26

The Goa University shall conduct **Goa University – Common Law Admission Test – II (GU-CLAT – II) 2025** for admissions to the three years LL.B. Programme for the Academic Year 2025-26.

The GU-CLAT II 2025 shall be conducted based on the following:

1. Eligibility:

Candidates who have passed graduation in any discipline from Goa University or any other University recognized as equivalent by Goa University and has obtained a minimum of 45% marks in aggregate (40% in case of SC/ST applicants and 42% in case of OBC applicants) at the final year of the Degree examination or an equivalent grade point shall be eligible for admission to the First Year LL.B.

Candidates who appeared for final year and results are not yet declared are also eligible to apply. Their admission shall be confirmed after the results are declared based on the eligibility. In case a candidate fails to clear the Graduation Examination, the admission shall stand canceled and the fees shall be refunded.

NOTE: Students awaiting their Graduation results may also apply for GU-CLAT II 2025-26.

2. Admission Criteria:

The Merit list shall be drawn based on performance at Qualifying Degree and GU-CLAT II 2025. There shall be 50%weightage for the marks scored at the Qualifying Degree Examination and 50% weightage for the marks scored in the GU-CLAT II 2025.

In-case candidates secure equal marks on merit lists (Qualifying Degree+ GU-CLAT II), GU-CLAT II marks shall be considered for breaking the tie.

3. Filling up of the Online Application Form for GU-CLAT II:

Admissions Portal Link: https://goaadmission.samarth.ac.in/

- a) The **LAST DATE** for submission of applications is <u>02nd June 2025.</u>
- b) The preference college selected by the applicant shall be the Test Centre respectively. Candidates are required to choose only one Centre and need not apply at both the Colleges.
- c) Digital copy of Passport size photograph, signature and Graduation are required to be uploaded in the online Application Form.
- d) Candidates are advised in their own interest to apply online much before the closing date and not wait till the last date for applying/payment of application fee to avoid the possibility of disconnection/inability/ failure to log on to the website on account of heavy load on the website.
- e) Goa University does not assume any responsibility to candidates in case they are unable to submit their application by the last date on account of the aforesaid reasons or for any other reason beyond the control of the University.

- f) Printout of the application form is **NOT REOUIRED** to be submitted to the University.
- g) Incomplete applications on Samarth Portal, shall not be considered for the GU-CLAT II.

Application Fees (Non-refundable) (To be paid online through SBI Collect only):

- INR 700 in case Un-reserved/EWS/OBC. *
- INR 350 in case of SC/ST of Goa. *
- No fees shall be charged from Persons with Disability.

Candidates applying for admission under EWS, should provide the certificate of Financial Year 2024-25.

Instructions for payment of Fee on SBI Collect:

- Click on link: https://www.onlinesbi.sbi/sbicollect/
- Select Educational Institutions as "Goa University"
- Select Payment Category as "Other Fees"
- Fill in the Payment Details+
- Click on Next and complete Verify Payment Details and to Complete Payment.
- Once the payment is completed, download the payment receipt.
- After the payment of amount on SBI Collect, the payment receipt is to be uploaded on DHE Samarth Portal. The Application shall not proceed forward unless Payment Receipt is uploaded on the DHE Samarth Portal.

4. GU-CLAT II 2025

The **GU-CLAT II 2025** shall be of One Paper of 100 marks, containing 100 Multiple-Choice Questions (MCQ) of 1 mark each. There shall be no negative marking. No marks shall be deducted for unanswered questions. The duration of the Test shall be 90 minutes.
