### Terms and conditions:

1. The sealed quotation super scribed "**Grass Cutting Activity around the Buildings, Roadsides, Pathways for the year 2025 (PHASE-I)**" should reach this office by 11.00 hrs on 27/06/2025 and will be opened on the same day at 11.30 hrs.
2. The quotation must accompany E.M.D of **Rs.8040.00** in form of DD/DCR of scheduled bank drawn in the favour of Registrar Goa University payable at Panaji. **The EMD as aforesaid should be enclosed in separate cover and attached to the cover containing the quotation.**
3. Security deposit at the rate of 10% of the gross amount of the work done shall be deducted from the bills.
4. Terms & conditions for execution of work as per CPWD form 6 & 7 shall be binding on the bidders.
5. The period for completing the work is 90 days to be reckoned from the 15<sup>th</sup> day of issue of order.
6. The quotation should be valid for 90 days for acceptance from the date of opening.

7. Quoted amount shall be exclusive of G.S.T and G.S.T as applicable shall be paid extra on total cost of the work done.

8. Self-attested copy of valid PWD Registration Certificate for registered contractors/Work Completion Certificates of similar work for specialized agencies, PAN card & GST Registration certificate should be enclosed with the quotation.


9. The contractor has to carry out the cleaning and clearing work of grass after cutting them. Cut grass has to be accumulated, transported and stacked at one place upto the distance of 3 km for disposal. The contractor will be fully responsible if fire catch for cut grass due to non-clearance and burnt area will not be considered for payment.

10. Quoted rate shall be inclusive of clearing, transportation, loading and unloading and stacking of cut grass. Nothing extra will be paid towards this work.

11. The University will provide the vehicle along with fuel and driver for transportation of the cut grass free of cost.

12. The right to accept or reject the quotation in the whole or in part is reserved by the Registrar Goa University.
