

NOTIFICATION

Final Round of Admission to various PG Programmes offered at Goa University and Affiliated Colleges (2025-26)

Based on the Goa University Admission Ranking Test (GU-ART), Schools on Goa University Campus and affiliated Colleges have admitted candidates to their respective PG Programmes.

The resultant vacancies for the various PG Programmes shall be filled through the following procedure:

1. All the interested candidates who have appeared for GU-ART 2025-26 (including candidates who were selected in earlier admission Rounds and forfeited their seats) seeking admission against the available vacancies and those candidates seeking transfer to another institute are required to submit their application to the respective Goa University School/affiliated Colleges/Programme Director/Principal via email or physical copy.
2. The last date **to submit the application at the respective Goa University School/affiliated College** shall be **21st July 2025, 01:00 pm.**
3. The Goa University School/affiliated College shall allot the vacant seats based on the order of Rank, only to those candidates who submit the application for the final admission round, on 22nd July 2025 and inform the selected candidates on the same date.
4. In case the vacancies arise due to transfer of candidate during the above steps of the process, the respective School/College is required to communicate immediately to the parent College where the student was admitted in the previous round/s. Such resultant vacancies shall be filled by 23rd July 2025.
5. The Rank list as mentioned in point number 3 above shall be followed throughout the process.
6. The respective Goa University School/affiliated College is required to share the final list of admitted Students to the Academic – Admission Section, Goa University, latest by 24th July 2025 in the enclosed format.
7. No seats shall be allotted to the candidates who have not answered any Rounds of GU-ART 2025-26.
8. Only in case of admission to the Master of Laws offered at Goa University School and affiliated Colleges, the Physical Counselling shall be conducted on 22nd July 2025 at 3.00 p.m. at Manohar Parrikar School of Law, Governance & Public Policy, Goa University.
9. All the applicants are hereby requested to note that this is the Final Admission Round for the various PG Programmes for the Academic Year 2025-26.
10. The **Last Date of Admission** for all the Programmes offered at Goa University Schools and affiliated colleges under Goa University Admission Ranking Test (GU-ART) for the Academic Year 2025-26 shall be **24th July 2025.** For the purpose of calculation of Refund of fees, the last date of admission shall be considered as **24th July 2025.**
