Terms & conditions:-

1. The Sealed Percentage rate Quotation superscribed "**Providing Rodent control treatment at Block-E, Science Bld. Goa University**" should reach the office by 11.00 am on **05/08/2025** and will be opened on the same day at 11.30 hrs.
2. The Quotation must be accompany E.M.D of **Rs.1470/-** in form of D.D/D.C.R of scheduled Bank drawn in favour of the Registrar, Goa University payable at Panaji. The EMD as aforesaid should be enclosed in separate cover and attached to the cover containing the aforesaid quotation.
3. Terms and conditions for execution of work as per CPWD form 6 & 7 shall be binding on the bidders.
4. The period for completion of work is 90 days and shall be reckoned from 7th day of issue of the work order.
5. The quotation should be valid for 90 days for acceptance from the date of opening of the quotations.
6. The rodent control to be carried out inside the premises by Glue pad and rat catch cages, outside the building by baiting and placing rod box. Also to stop the entry by hanging cables and pipelines by capfitting.
7. The services of bait, glue pad, boxes should be provided fortnightly (15 days) for a duration of total 90 days and disposal of the carcass to be carried out within 2 days or as & when complaint is received.

8. Quoted amount should be exclusive of G.S.T. The G.S.T as applicable shall be paid extra on the total amount of work done

9. Bidders shall enclose self attested copies as below:-

- i) Valid Pest Control Licence issued by Government of Goa.
- ii) Valid Shop establishment Certificate or Trade licence in relevant trade with the quotation.
- iii) GST Registration certificate.
- iv) PAN Card.
- v) Work completion certificate or documents showing services of similar works in last three years ending June 2025.

10. The right to accept or reject the quotation in whole or in part is reserved by the Registrar, Goa University.
