The above walk-in-interview will be held in the Council Hall, Administrative Block, Goa University.

**The minimum qualifications for appointment to the post of Assistant Librarian shall be:**

**Eligibility:**

- (i) A Master's Degree in Library Science, Information Science or Documentation Science or an equivalent professional degree, with at least 55% marks (or an equivalent grade in a point –scale, wherever the grading system is followed) A consistently good academic record, with knowledge of computerization of a library.
- (ii) Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC, CSIR or similar test accredited by the UGC like SET or who are or have been awarded a Ph.D. Degree in accordance 467 with the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil./Ph.D. Degree) Regulations, 2009 or 2016 and their amendments from time to time as the case may be.

(iii) Provided that the, candidates registered for the Ph.D. degree prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinances / Bye-laws / Statutes of the Institution awarding the degree, and such Ph.D. candidates shall be exempted from the requirement of NET/SET for recruitment and appointment of Assistant Professor or equivalent positions in Universities/Colleges / Institutions subject to the fulfillment of the following conditions:-

- a) The Ph.D. degree of the candidate has been awarded in the regular mode.
- b) The Ph.D. thesis has been evaluated by at least two external examiners.
- c) Open Ph.D. viva voce of the candidate has been conducted.
- d) The Candidate has published two research papers from his/her Ph.D. work, out of which at least one is in a refereed journal.
- e) The candidate has presented at least two papers based on his/her Ph.D work in conferences/seminars sponsored /funded/supported by the UGC/ICSSR/CSIR or any similar agency.

The fulfilment of these conditions is to be certified by the Registrar or the Dean (Academic Affairs) of the University concerned.

Note: NET/SET shall also not be required for candidates in such Master's Programmes for which NET/SET is not conducted by the UGC, CSIR or similar test accredited by the UGC like SET.

In addition to the requirements specified above, the following mandatory requirements shall be applicable for the post of Assistant Librarian:

**a) Minimum of 15 years of Residence in Goa.**

**b) Knowledge of Konkani.**

**Additionally, Knowledge of Marathi shall be desirable.**

**Instructions:**

Only candidates having prescribed qualification and meet the essential conditions will be allowed to appear for the interview.

Candidates should register their names in the office of the Assistant Registrar (Teaching), Administrative Office, Goa University half an hour before the scheduled time of the interview.

Application on plain paper addressed to the Registrar, Goa University, bio-data with self-attested copies of valid caste certificate, valid residence certificate and

certificates pertaining to educational qualification shall be submitted at the time of registration.


Candidate shall produce the original certificates for verification during the interview.

Candidates appearing for interview will have to present themselves at their own expenses. No TA/DA will be paid to the candidates.

University reserves the right not to fill up the position/cancel the selection process at any point of time without assigning any reasons and no expenses/refund shall be payable to any applicant in such cases.

If selected, the appointee shall have no claim whatsoever for any permanent post due to this appointment as this is against leave vacancy.
