A programme is also required to be conducted on demonstration on Drug Detection in various colleges in the State of Goa.

For that purpose, your goodself is required to accord your kind cooperation in this regard and issue necessary directions and instructions to the Principals of Colleges in the State of Goa, to conduct the said programmes/workshops in Colleges as follows :

- (a) Conduct awareness talks on the topic “Drug Abuse – Drugs : A Menace to the Society”.
- (b) Workshop in the Colleges and Youth Clubs on the said topic.
- (c) Police – Student Interaction Session.
