3. To keep abreast of the decision of the District Level Anti-Ragging Committee.
4. To review the efforts made by the Educational Institutions to publicize anti-ragging measures, soliciting of undertakings from parents and students for each academic year to abstain from ragging activities or willingness to be penalized for violations.
5. To function as the prime mover for initiating action on the part of the appropriate authorities of the Goa University for amending its Statues or Ordinance or Bye-Laws as the case may be and to facilitate the implementation of Anti- Ragging measures at the level of the Institutions.
6. To send the State Level Monitoring Cell, the status reports periodically and at such frequencies that it may lay down.

The Directorate of Student Welfare will extend the required logistics for the smooth functioning of the Cell.

The tenure of the Monitoring Cell shall be for the period of three years from the date of issue of this Order.
