The Principal of V.M. Salgaocar College of Law, Miramar- Goa & G.R. Kare College of Law, Margao- Goa are hereby informed that the date for filling and submission of exam forms of the B.A.LL.B. and LL.B. Degree (CBCS) courses for admission to the Semester End Examination (SEE) to be held in **April, 2026** will be as follows:

1. Programmes:

- B.A.LL.B. & LL.B. DEGREE (CBCS)

2. Date of Commencement of Examinations: **15/04/2026**.

3. **Instruct the students to register on ABC portal for ABC ID**

4. **Steps Involved in Exam Registration (Students):**

- I. Submission of the Online Exam Form will begin on **11/03/2026**.

II. **ABC ID is compulsory for exam registration.**

- III. Students answering Semester II and IV (Regular) & I and III (Repeat) will register on the University portal but pay the exam fees to the respective colleges. Students are instructed to download & print the exam form and **submit it to the HOD for correctness of papers/no. of credits.**

- IV. Exam Forms without late fees will be opened up until **20/03/2026 05:00 PM**.

- V. After **20/03/2026 05:00 PM**, a Late Fee of **₹355/-** will be applicable till **25/03/2026**.

No Further Extension will be allowed.

5. **For Principals:**

- I. A list of Students who have submitted the exam form will be mailed to the principals at the end of each day. A final consolidated list will be sent on **26/03/2026**.
- II. Discrepancies, if any, should be reported to the Exam PG (exampg@unigoa.ac.in) with a CC to COE (coe@unigoa.ac.in) and AR-Exam PG (arexampg@unigoa.ac.in) by **30/03/2026**. Even if no Discrepancy is reported, the NIL report is to be sent compulsorily. Changing the Subject/Papers will not be allowed. (format enclosed).
- III. Fees are to be collected by the college from students by **30/03/2026** based on the list sent by Goa University on 26/03/2026.
- IV. College to report to the COE on or before **02/04/2026** by email the list of students who have not paid the fees as on 30/03/2026 without fail.

- V. 90% of fees are to be remitted to University on or before **05/04/2026**.
- VI. List of ISA defaulters/Ineligible candidates should be submitted by **05/04/2026**. Even if there are no students, the NIL report is to be sent without fail.
- VII. **The candidate list / Admit card will be generated only after the submission of the NIL reports.**
- VIII. By **10/04/2026**, Candidate List and Admit Cards will be generated and sent to colleges by Goa University. Changing the Subject/Papers will not be allowed once the Candidate List & Admit Cards are generated.
- IX. Principals are advised to ensure that the marks are sent to the Exam Division on or before the following days:
 1. ISA Marks on or before **12/04/2026**.
 2. NCC/Cultural Marks duly signed by the concerned, if any, on or before **13/04/2026**.
 3. NSS/Sports Marks to the concerned In-Charge/Coordinator on or before **10/04/2026**. NSS/Sports marks are not to be sent directly to COE or AR-Exam(PG).
