Steps Involved in Exam Registration :-

- I. Online Paper Registration will begin from **19th March 2025**.

- II. Part-II Students have to complete the online paper registration using their P.R No. and OTP which was used while applying for Earlier Semester Examinations.
Paper registration will be opened upto **25th March 2026, midnight**.

- III. Immediately after Paper Registration, student shall complete online Exam Form by payment of fees through **SB Collect** by **29th March 2026**.
After 29th March 2026 Late Fee of Rs 355/- will be applicable till 02nd April 2026. No Further Extension will be allowed.
- IV. **The receipt generated in SB Collect portal needs to be uploaded on exam portal & download the acknowledgment receipt without which the form will be considered incomplete and form will be rejected.**
- V. **Students have to submit the acknowledgment receipt to their respective College office.**

3) For Course Coordinator of the Affiliated Colleges:-

- I. On **03rd April 2026**, a PDF report will be sent to the Affiliated Colleges to report Discrepancies and eligibility response to **Goa University**. Even if no Discrepancy is reported, NIL report must be sent to Email-ID: arexampg@unigoa.ac.in, jrprog4@unigoa.ac.in by **04th April 2026**
- II. **Examinations Time-Table** to be sent to the University by the respective Affiliated Colleges by **02nd April 2026**.

III. By **06th April 2026**, Candidate List and Admit Cards will be generated and sent to respective Affiliated Colleges.

IV. By **06th April 2026**, Blank Marks Input Forms of ISA/ SEA/ Practical/ Project will be sent to respective Affiliated Colleges.

V. ISA marks (Hard copy and Soft Copy) to be submitted to the University **by 15th April 2026**.

VI. Entitlement marks (NCC/Cultural) if any to be submitted by **15th April 2026**, duly signed by Competent Authority.

Sports Marks, if any, may be sent to Exam-PG office by **15th April 2026** only upon ensuring certification by duly signed by Competent Authority.

NSS marks, if any, may be sent to Exam-PG office by **15th April 2026** only upon ensuring certification by duly signed by Competent Authority.

VIII. SEA marks(Hard copy and Soft Copy) to be submitted to the University by **19th May 2026**.

5) **No Forms will be accepted in the examination section beyond dates mentioned.**
