

**Name of the College: Swami Brahmanand Mahavidyalayam, Kundaim**

**Observations:**

The first and ground floor which has an area of approximately 250 sq. mts has the following rooms:

Library with seating capacity for only 16 students.

The society has an available area of 1, 98,000 sq. mts.

Ladies and Gents wash room.

One classroom for first year B.A. with a seating capacity for 20+ students

Two rooms purportedly meant for Ladies/Gents common rooms.

Play area is available opposite the proposed College building.

Shree Brahmanand Sanskrut Prabhodhini which proposes to run the college is registered under the Societies Registration Act, 1860.

The first and ground floor from where the proposed College will function will be on rent. The building is owned by P.P. *Shree Padmanabh Shishya Sampraday Trust*.

**Essential Conditions to be fulfilled before the start of the academic year 2016-17.**

Required Faculty and Librarian to be appointed as per SA-19 and approved by the University.

A total of 1000 books or a minimum of 100 books in different titles on each subject as per the syllabus, reference books, two academic journals per subject and book bank facility may be procured/made available.

Corpus Fund by way of joint FDR of Rs 15 lakhs may be made. (SC-1 2.(b)).

Present library which has a seating capacity of 16 students may be shifted to a bigger place before beginning of the academic year 2017-18.

As per SC-1 (iii) 3, College to move to the proposed permanent building by the beginning of the third year.

Staff room, Principal's room and Office space for administrative staff to be identified and earmarked.

Required administrative staff to be recruited.

The identified classroom may be equipped with appropriate furniture.

Second classroom to be identified and earmarked for S.Y.B.A. students during the academic year 2017-18.

Internal Complaints Committee as per Vishaka Judgement to be constituted

**Overall recommendations of the AIC:**

AIC recommends affiliation to Shastri-B.A. (Sanskrit) for the academic year 2016-17 subject to fulfillment of essential conditions and suggestions and approval of the syllabus by the Academic Council. The College to submit the compliance report on the essential conditions and suggestions after which the AIC will re-visit the College to check the compliance.

**Suggestions of the AIC:**

Courses run by the College affiliated to other University may be discontinued after affiliation by Goa University.

Anti-ragging Committee to be constituted.

Managing Committee and Local Managing Committee to be constituted.

Budget for the financial year 2016-17 may be prepared.

Separate common room for boys and girls to be identified and earmarked.

Fee structure to be approved by DHE.

Play area to be developed.

Canteen to be identified and health care facilities to be provided.
