Letter No.4-7/2021-22/NCH (MA & RB) (108-01)/3749 dated 08.12.2021 has denied permission to Shri Kamaxidevi Homeopathic Medical College, Shiroda-Goa for admitting students to the First Year BHMS Programme with intake capacity of 50 seats for the academic year 2021-2022, due to non compliance of deficiencies conveyed to the College vide their letter dated 18.10.2021.

After detailed discussion and in view of Clause 6. of the Denial Order received from the National Commission for Homoeopathy, the Standing Committee of the Academic Council decided to withhold affiliation to admit students to the First Year BHMS Programme for the academic year 2021-22.

It was also suggested to request the college to inform this decision to the Stakeholders.
