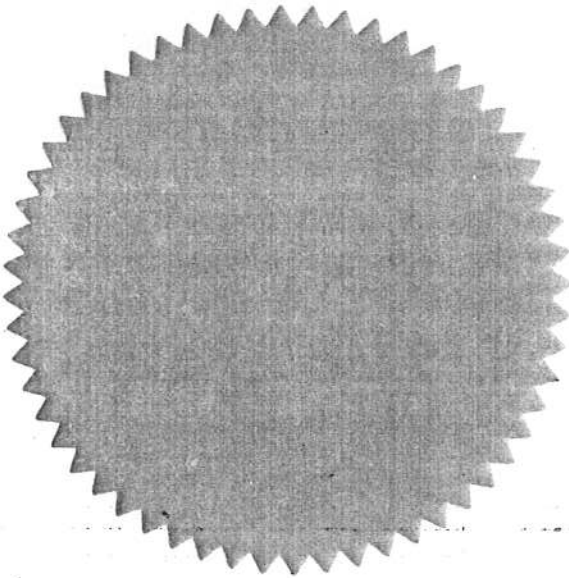

Conference Hall has appropriate seating arrangement on the dais for the Presiding Officer of the Tribunal and also seating arrangement for the Advocates and the litigants.


3. The Counsel for the petitioner submits that an appeal has already been submitted to the Executive Council of the Goa University.
