**ORDER**

1. The information seeker, Ms. Lida Joao herein by her application dated 26/04/2016 filed under section 6(1) of the Right To Information Act, 2005 sought certain information from the Public Information Officer (PIO), Assistant Registrar (Academic Colleges), Goa University, Taleigao-Goa
2. The said application was transferred by the PIO of Goa University to the PIO of Shivgram Education Societies Shri Kamaxidevi Homeopathic Medical College and Hospital "Shiv Shail" Shiroda-Goa, under section 6(3) of the RTI Act on 29/04/2016.
3. Being aggrieved by the failure of the Respondent to provide her information sought, the Appellant filed an first appeal to the First Appellate Authority (FAA) on 20/06/2016 under section 19(1) of the RTI Act 2005. The said appeal was filed against the PIO of Goa University, Taleigao-Goa which was dismissed by FAA.
4. Being aggrieved by the action of FAA, this second appeal came to be filed on 16/09/2016 there by seeking prayer for

direction as against Respondent/PIO for furnishing her information as sought by her vide her application dated 26/04/2016 and for invoking penal provisions.

5. In pursuant to the notice of this Commission the appellant appeared in person. Respondent no. 1 PIO was represented by Advocate Ashwini Agni. Reply filed by the Respondent on 17/04/2017.
6. In the course of hearing the PIO offered to furnish the information to the appellant at point number 7. Accordingly the same was furnished to the appellant. On verification of the said information, the Appellant submitted that the information is furnished to her is to her satisfaction and as per her requirement. She further submitted that she has no any grievance against present PIO, and that she is not pressing for penal provisions. Appellant also sought leave to file fresh RTI application for remainder information. Accordingly she endorsed her say on memo of appeal.
7. In view of submission and acknowledgement made by Appellant, I find no reasons to proceed with appeal. Hence Appeal stands disposed by granting liberty to the Appellant to seek additional information with regards to same subject matter if she desires.
8. Proceeding stands closed.

Notify the parties.


