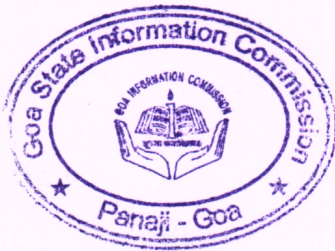

3. Reply filed by Respondent PIO on 15/3/2017 to which counter reply was filed by complainant on 5/4/2017 .
4. On 9/2/2018 advocate H. Modi holding for Advocate A. Agni verbally sought lieu to amend the reply of PIO dated 15/3/2017 at para 7 (line 10 to 14). As the said was not objected by complainant, the Advocate for the respondent was permitted by this commission to carry out the necessary amendment.
5. The complainant then submitted that the purpose for which the said information was sought have been served and on that ground
