ORAL JUDGMENT: (Per Bharati Dangre, J.)

1. Rule. The rule is made returnable forthwith with the consent

of and at the request of the learned counsel appearing for the parties.

2. Pursuant to the notice issued to the respondents, the learned

Additional Government Advocate representing respondent nos. 1 and

2 has placed before us the decision taken by the Director of Health

Services, regarding superannuation age of teaching staff of the Institute

of Nursing Education dated 07.05.2025. This has reference to the

communication dated 25.04.2025 issued by the Under Secretary

(Health-II) from the Public Health Department, by which the Director

of Health Services is informed that as per the provisions of Section 15A

of the Goa University (Amendment) Act, 2009, the age of

superannuation for the teaching staff of Goa University and its affiliated

colleges including Principals, whether aided by the Government or not

shall be 62 years.

The said communication dated 25.04.2025 categorically states

that as the Institute of Nursing Education is affiliated to Goa

University, it shall strictly adhere to the guidelines dated 30.08.2012

issued by Goa University, which had determined the age of retirement

as 62 years.

This decision is found to be reiterated in the communication addressed by the Director of Health Services to the Director, Administration Section, Director of Health Services, Panaji.

- **3.** The aforesaid communication placed before us by the Government Advocate is taken on record and marked as 'X' for identification.
- 4. In the wake of the aforesaid decision, the petitioner, who was made to retire from the post of Sister Tutor on attaining age of 60 years w.e.f. 28.02.2025 deserves to continue in service since it is now decided by the Government that the age of superannuation for the teaching staff of Goa University would be 62 years, and this includes teaching staff from the Institute of Nursing Education.
- 5. Though the respondent no.3 Institute of Nursing Education is not before us, we must clarify that as indicated in the communication dated 07.05.2025, the Institute of Nursing Education being affiliated to Goa University is bound by the decision and for the teaching staff working in the said Institution, the age of superannuation being 62 years, the petitioner deserves to continue in services till she attains the age of superannuation.

Needless to state that the petitioner shall be permitted to resume her duties. Since the petitioner was made to retire in the month of February 2025, a decision shall be taken continuing her services in all

aspects including continuity, payment of salary as well as counting of her continuous service for the purposes of pensionary benefits.

In the wake of the aforesaid, the Writ Petition is made absolute 6. in terms of prayer clause (a). The petitioner shall continue her services till she attains the age of 62 years.
