UPON hearing the counsel the Court made the following
O R D E R

1. This Special Leave Petition has been filed by the petitioner against the order dated 25.09.2025 passed by the High Court in Writ Petition No. 2491 of 2025, with a prayer to permit him to appear in the re-examination of one of the subjects in B.Sc., in which he had

failed. His application for re-examination was rejected on the ground that the same was made after the last date i.e. 19.09.2025.

- 2. The High Court, by the impugned order, dismissed the writ petition on the ground that the petitioner did not apply within the last date, being 08.09.2025 initially, and even before the extended date i.e. 19.09.2025.
- 3. We have heard learned counsel appearing for the parties and having perused the counter affidavit filed by the respondent State of Goa, in the peculiar facts and circumstances of the case, we direct that the petitioner should be allowed to appear in the examination, to be held on 25.10.2025.
- 4. We make it clear that this order is passed in the facts and circumstances of the present case and our directions should not be treated as a precedent in any other case.
- 5. The petitioner will submit his application and shall complete all formalities by tomorrow i.e. 18.10.2025 positively.
- 6. With these directions, the Special Leave Petition is disposed of and all accompanying interlocutory applications, if any, stands disposed of.
