D 1.4.2 (i) Regarding pay and allowances of the Vice-Chancellor.

The Registrar informed the House that Prof. H. B. Menon had taken over the charge as Vice-Chancellor of Goa University w.e.f. 03/09/2021 (A.N.) by keeping a lien on his position of Senior Professor in the School of Earth, Ocean & Atmospheric Sciences. He superannuated from the said position on 31/07/2024(A.N.). Therefore, the matter is placed before the House for decision on fixation of his pay as Vice-Chancellor as per the relevant Statute. Prof. H. B. Menon, Vice-Chancellor recused himself during the discussion on the said item.

RESOLUTION XV: The Executive Council approved fixing the pay and allowances in respect of Prof. H. B. Menon, Vice-Chancellor as per the provisions of Statute SA-6(2) with effect from 01/08/2024 as under:

- (i) Pay like a re-employed pensioner i.e. Pay for the post of the Vice-Chancellor less basic pension (w.e.f 01/08/2024);
- (ii) House Rent Allowance;
- (iii) Transport Allowance on the pay of the post; and
- (iv) All other allowances as admissible, including Dearness Allowance.

Further, it was decided to forward the above decision to the State Government for approval.

D 1.4.2 (ii) To create two posts of Senior Laboratory Technician in pay Level–5.

The Members were informed that there are five sanctioned posts of Laboratory Technician in the pay Level–4 and presently all the posts are filled as per the then RRs of GU. The said five positions of Laboratory Technician were created 27 years ago and over the time, the science disciplines of University have been expanded in terms of number of faculty members, students and infrastructure. This has also increased demand for such technical positions. There are no promotinal avenues for Laboratory Technician; therefore, it is proposed to create the two posts of Senior Laboratory Technician in Level-5 and approve the Recruitment Rules for their promotion.

RESOLUTION XVI: The Executive Council approved to create two posts of Senior Laboratory Technician in pay the Level-5 at Goa University. It is also decided to forward the proposal along with the Recruitment Rules to the State Government for approval before further implementation.

D 1.4.2 (iii) To rename Legal Assistant of University as Junior Law Officer and creating suitable posts for promotion of Junior Law Officer.

The Registrar informed the House that University has one Sanctioned post of Legal Assistant in Level-6 and is filled at present. Presently there are no promotional avenues for Legal Assistant in the University.

As per Official Gazette, Series I, No. 40 dated 31st December 2020, the scale of pay and RRs of Junior Law Officer is same as that of Legal Assistant. There is also further promotion to the said post as Assistant Law Officer and Senior Law Officer as per said Gazette. To create promotional avenues for the post of Legal Assistant, it was proposed to rename Legal Assistant as Junior Law Officer and to create its subsequent promotional positions at Goa University as per the Government RRs.

Further, it was informed that, presenty there is no Assistant Registrar having suitable qualification for posting in the Legal Section and the previous AR(Legal) is promoted to Deputy Registrar position. Thereafter, it was decided by the House to rename the said position as Assistant Registrar from Assistant Registrar (Legal).

RESOLUTION XVII: The Executive Council approved to rename the existing post of Legal Assistant, Goa University as Junior Law Officer as per the Official Gazette, Series I, No. 40 dated 31st December 2020.

Further, the House approved to create the one post each of Assistant Law Officer and Senior Law Officer at Goa University and also approved the Recruitment Rules for the said positions.

Further, it was decided to forward the above proposals to the State Government for its approval before further implementation. Upon approval of the above proposal by the Government the imcumbument Legal Assistant will be redesignated as Junior Law Officer.

The motion was moved by Prof. Anuradha Wagle, Dean, Shenoi Goembab School of Languages and Literature on behalf of the Dean, Goa Business School, Dean, School of Chemical Sciences, Dean, School of Earth, Ocean & Atmospheric Sciences, Dean, Manohar Parrikar School of Law, Governance and Public Policy, Dean, School of Physical and Applied Sciences, Dean, D. D. D 1.8 (ii) Ph.D Evaluation Report in respect of Ms. Preeti Ramesh Kamat Shankhawalkar received from the third External Examiner.

The Registrar informed that among the three Ph.D evaluation reports received in repsect of Ms. Preeti Ramesh Kamat Shankhawalkar, for her Ph.D. thesis in English at Shenoi Goembab School of Languages & Literature, two were postive. Though the third repot was negative, as per the provision of ordinance, the viva-voce was conducted on 26/07/2024. Therefore, the matter was brought to the House as per the provisions of Ordinance OB-9A.9(x)(a).

The members deliberated in the matter and made the following suggestions:

- Amendment to be made to the relevant clause when one of the reports is negative and recommends for rejection of the thesis.
- To obtain Legal opinion before taking steps towards suitably amending the existing provisions of Ph D Ordinance.

RESOLUTION XXI: The Executive Council noted the recommendation of rejection of thesis submitted by Ms. Preeti Ramesh Kamat Shankhawalkar for her Ph.D. thesis in English at Shenoi Goembab School of Languages & Literature by her third examiner.

The Executive Council also noted that two examiners have already given favourable report regarding the Ph.D. thesis of Ms. Preeti Ramesh Kamat.

After deliberations, the House decided to obtain legal opinion in the matter to decide further course of action like suitably amending relevant provisions of the ordinance related to minimum number of positive reports required to conduct viva-voce examination.

D 1.8 (iii) To Consider and decide on the "Show Notice cum Demand notice issued under the provisions of Section 74 read with Section 122 of the Central Goods & Services Tax Act, 2017".

It was informed that the University has received "Show Notice cum Demand Notice issued under the provisions of Section 74 read with Section 122 of the Central Goods & Services Tax Act, 2017" from the Office of the Commissioner of CGST & Central Excise, Panjim, regarding Payment of GST by Education Boards on affiliation services provided to Colleges and also on other receipts like Sports, Cultural activities, Examination etc.

Further, it was informed that the educational services for courses recognized by law are not intended to be taxed under GST so that it doesn't become additional cost burden for the students and that such courses are a part of the process of imparting education to university students which are not taxable services.

It was also informed that the University also had thorough discussion with the Chartered Accountant Mr Yatish Vernekar and his team and it was suggested to approach the High-Court. The Registrar also mentioned about some Senior Advocates who have successfully taken up such matters for other Universities.

RESOLUTION XXII: The Executive Council after deliberations decied in principle to file a petition before the Hon'ble High Court against the Show Notice cum Demand Notice issued by the Office of the Commissioner of CGST & Central Excise, Panajim, regarding Payment of GST by Education Boards on affiliation services provided to Colleges and also on other receipts like Sports, Cultural activities, Examination etc.

The House also agreed to use services of suitable lawyers in consulation with the University Chartered Accountant.

D 1.8 (iv) To consider the application of students pertaining to Challenge Evaluation.

The Registrar informed the House that, Ordinance OA-25 relating to Challenge Evaluation in the SEE/SEA/University Examination Component of Theory Course/s (w.e.f. 12th March, 2018) was repealed on 03/07/2024 and the same was notified vide Notification No.2/738/2024-Legal/(Vol-XXIX)/418 dated 12/08/2024. During this period several Colleges have forwarded requests for Challenge Evaluations received from their students and since the students were not aware about this new change, it is proposed to extend the facility of Challenge Evaluation to all the examinations notified prior to 12thAugust, 2024.

RESOLUTION XXIII: The Executive Council approved to extend the date of accepting applications/requests for Challenge Evaluation to all the examinations which were notified before 12th August, 2024. Further, it was decided that no such requests for Challenge Evaluation will be entertained for the examinations notified after 12th August, 2024.

These courses are for officers from the Indian Armed Forces and friendly foreign countries and are not for academic degrees but for professional certification. The Academic Council in its meeting held on 14.06.2024 has approved the proposal for Joint

Certification of the Indian Navy's 'Short Term Professional Certificate' Course entitled 'Regional Maritime Security Course', offered by the Naval War College through the integral involvement of the School of International and Area Studies, Goa University. The course syllabus and certificate template have also been approved by the Academic Council.

- 2. To identify the bottlenecks in the existing administrative mechanisms and the opportunities for academic reforms, administrative reforms, examination reforms, etc.
- 3. To evaluate the optimum utilization of financial and other resources.
- 4. To suggest methods for continuous quality improvement, keeping in mind different criteria and reports by NAAC and other bodies.

RESOLUTION XXV: The Executive Council approved the proposed Academic & Administrative Audit Policy of Goa University.

D 1.8 (vii) Leasing of University's land to Government for Academic purpose.

The Registrar informed that this House in its meeting held on 24/04/2023 had in principle resolved to prepare and finalize of MOU between the Goa Government and Goa University against the request made by the Government for land for the purpose of the Research Park.

Further, it was informed that the University had requested the Government to sanction approximately Rs.107 Crores for its plan towards infrastructural expansion over the next few years. In response to this, the DHE, Goa requested 200,000 sq.mt. of the University land be transferred to the Government to relocate several Government colleges, including Pharmacy, Architecture, Home Science, and Music, to the GU Campus.

Further, it was informed that to develop University in to MERU, Schools such as Pharmacy, Architecture, and Performing Arts, are imminent and will play a crucial role. Therefore, it

was proposed to accept the above Collges as constituent Schools of the University to which the Secretary (Education), Government of Goa & Hon'ble Member of the House had informed that the said proposal is refused by the concerned Colleges and the Government has an affirmative approach to the same. When the delegation of Executive Council met the Hon. Chief Minister and there after Hon'ble Chancellor to convey the resolution passed by the House regarding transfer of said Government Colleges as constituent Schools/ Colleges of the University, the same was not accepted by the Hon'ble CM and opined that these colleges will be independent entities and in futre it can be conssituent colleges a per the NEP guidelines.

The Goa University in discussion with the Hon'ble Chancellor, has now proposed to lease the identified land to the Government for Academic purpose, first for a period of 33 years thereafter renewal to another 66 years against a suitable MOU between the University and the DHE/ Government of Goa. It was also informed that presently, the University does not have a single piece of land admeasuring 2 lakh sq mt for leasing. The identified land admeasuring an area of about 1.35 lakh sqm was presented to the Hon'ble members of the House during the meeting.

The Members deliberated on the matter and suggested that suitable compound walls surrounding each building of the Univeristy along with walls on either side of the MDR to be erected. This is highly essential for the safety of students and staff. In view of this, the University should therefore request funds to the tune of Rs 150 crore instead of the initial request of Rs 107 crore.

RESOLUTION XXVI: The Executive Council resolved leasing of the identified land of Goa University to the Government for Academic purpose, first for a period of 33 years and then renewal to another 66 years.

Further, it was resolved to sign suitable MOU between the Goa University and the Directorate of Higher Education for the said purpose with the inclusion of the following points in the MOU:

- The Government should not change the present land use plan from the institutional or education purpose to anything else in future and shall construct infrastructure and facilities only for higher education purpose.
- The Government should not permit diverting any traffic inside the land leased to Government to the internal parts or existing internal roads of University and the transportation or traffic requirements for the new development shall be managed accordingly.
- The Government should provide requested funds approx. Rs 150 Crore for various development requirements of the University on priority basis. This includes New Administrative Annexe Building, support for starting Biomedical/ Bioengineering program, renovation of old guest house, VC and

Registrar bungalows, facilities for Physical Education program, construction of compound walls around individual buildings and on either side of MDR.

- The colleges and institutions transferred or any other academic institution built in the leased land shall continue to remain affiliated to Goa university or in future may become constituent institutions of the Goa University.
- The facilities that may be generated by the Government for the education purpose for these new newly transferred institutions should also be available to the other students and faculty of Goa University campus.
- The Government to reconstruct the compound wall across the new boundaries that will be generated for the University at its own cost.
- The Government should do the needful w.r.t. pending approvals from TCP Board w.r.t. various proposals of the Goa University including those for recent construction projects under PM-USHA funding.

The Registrar informed that Smt. Kirti Kankonkar and Shri Ashwin Lawande have joined as Deputy Registar, Goa University w.e.f. 29/06/2024 and had requested to keep one year lien on their position of Assistant Registrar at Goa University. The said request was approved by the Vice-Chancellor on behalf of the Executive Council.

RESOLUTION XLIII: The Executive Council ratified the decision taken by the Vice-Chancellor in approving to grant lien in respect of Smt. Kirti Kankonkar, Deputy Registrar (Administration) and Shri Ashwin Lawande, Deputy Registrar (Academic) for their previous position of Assistant Registrar at Goa University, for a period of one year.

R1 (**xvii**) Termination of Lien period of Dr. Prabhakar Palni, Assistant Professor, School of Physical & Applied Sciences, Goa University.

The Memebers were informed that Dr. Prabhakar Palni, Assistant Professor, School of Physical & Applied Sciences, Goa University was granted one year lien on his post w.e.f. 01/02/2023 and was relieved to join the Dept. of Physics, IIT Mandi Kamand, Himachal Pradesh w.e.f. 31/01/2023 (A.N). He was further granted an extension of lien for a period of six months. Dr. Palni vide his email dated 16/08/2024 formally communicated his decision not to extend his lien any further.

RESOLUTION XLIV: The Executive Council noted the termination of lien period of Dr. Prabhakar Palni for his position as Assistant Professor in the School of Physical & Applied Sciences, Goa University.

R1 (xviii) Matter regarding Sports Marks to the BPEd Degree Students.

It was informed that the University vide its circular No.GU/Acad(Colg)/National Games/2022-23/68 dated 17/10/2023 had approved awarding of marks and/or credits to various students who offer their services as volunteers during the National Games 2023 and the specific provision made for Sports students was as under:

Sports Students who volunteer for entire duration of the National Games the National Games preceded by training/orientation/induction period, shall be awarded 10 marks.

While the other student volunteers were awarded the said marks in a suitable manner, the BPEd Degree students were excluded considering the provisions of OC-62.4(1)(c)(vi) which does not permit giving benefit of above said 10 marks to the BPEd Degree Students. The above circular had also clarified that the facility will be applicable to only those student volunteers who were deputed by the DHE. The list of students received from the DHE also had the names of students perusing BPEd Degree. Since, the provision of OC-62.4(1)(c)(vi) does not include any provision towards volunteering in a major sports activity but only

involves participation in the Sports activities, the Vice-Chancellor had agreed to revise the result of the BPEd students by giving them benefit of 10marks on par with other eligible students.

RESOLUTION XLV: The Executive Council ratified the decision taken by the Vice-Chancellor to revise the result of the BPEd Degree students, who had offered their services as volunteers for the National Games 2023, by extending the benefit of sports marks to them on par with the other eligible students.

R1 (xix) Grant of Letter of Consent for affiliation to Goa College of Veterinary & Animal Sciences, Curti-Ponda, Goa.

The Registrar informed the House that on recommendation of the Standing Affiliation Inquiry Committee the Affiliation Inquiry Committee visited the Goa College of Veterinary and Animal Sciences, Curti, Ponda, Goa on 13.08.2024 and submitted its Report. In view of urgency, the report of the Committee recommending affiliation to start the proposed Bachelor of Veterinary Science and Animal Husbandry (B.V.Sc. & A.H.) Programme for the A.Y. 2025-26 and the permission to issue Form IV & V to the said College for applying for recognition of the Veterinary Council of India, was approved by the Vice-Chancellor on behalf of the Academic Council and Executive Council.

RESOLUTION XLVI: The Executive Council ratified the decision of the Vice Chancellor in approving the report of the Affiliation Inquiry Committee recommending affiliation to the Goa College of Veterinary and Animal Sciences, Curti, Ponda, Goa to start the Bachelor of Veterinary Science and Animal Husbandry (B.V.Sc. & A.H.) Programme for the Academic Year 2025-26 and to grant permission to issue Form IV & V to the said College for applying for recognition of the Veterinary Council of India.

A.O.B.(1): Recommending extension to the service of Shri Sangam Talaulikar, Executive Engineer w.e.f. 01/01/2025

The Registrar informed the House that Shri Sangam Talaulikar, Executive Engineer is presently officiating as University Engineer of Goa University and will superannuate on 31/12/2024. He has been working at the University from the last 34 years since March 1989 and has put in excellent services.

Currently, seven major projects planned under the PM-USHA scheme sanctioned to Goa University are required to be completed by March, 2026. At present, there are only two senior engineers serving as Executive Engineers including Shri Talaulikar. The other Executive Engineer, Shri Sachin Narvekar is also due for superannuation on 31/10/2024. With the superannuation of both these engineers, the University will not have any senior

officer to handle the Engineering Division work which majorly includes completion of infrastructure and tendering work going on under the PM-USHA scheme sanctioned to Goa University. Since, no manpower is available for promotion to the aforesaid position, it is felt necessary to extend the services of Shri Talaulikar for a further period of one-year w.e.f. 01/01/2025. Shri Talaulikar has also informed that, he is willing to offer his services to the University for further period of one year even after his superannuation in the interest of the institution.

RESOLUTION XLVII: The Executive Council approved to extend the services of Shri Sangam Talaulikar, Executive Engineer, Goa University for a further period of one year w.e.f. 01/01/2025 in view of the infrastructure and tendering work of University going on under the PM-USHA Scheme. This will however, be subject to the approval from the State Government.
