CIRCULAR

Sub: Student Registration - Academic Year 2010-11.

Principals / Deans of the Professional & Non Professional Colleges / Institutes affiliated to Goa University are hereby requested to adhere to the following guidelines with regard to the registration of students during 2010-11.

#### I. Enrolment

- 1. Colleges are required to admit students to the First Year of the Bachelor of Degree Programme Classes and new entrants (from other Universities) to S.Y. & T. Y. Classes in their respective colleges on the basis of their having passed the Higher Secondary Certificates Examinations conducted by the Goa Board of Secondary & Higher Secondary Education or on the provisional Eligibility Certificate issued by the Goa University. Photocopy of the Marksheet and Certificates shall be retained by the college.
- 2. The programme wise list of the students admitted are to be sent to the University for records.

#### II. Registration

- 3. The colleges are required to collect a Registration Fee of Rs. 440/- from each of these students (both Enrolment as well as Eligibility cases) admitted. A fee of Rs. 25/- is to be retained by the respective college to distribute as remuneration among the staff involved in registration work.
- 4. In regards to registration the following may be noted:
- a) The registration forms along with the photograph and registration fee collected should be remitted to this University by means of Demand Draft drawn in the favour of Registrar, Goa University on State Bank of India, Goa University latest by 18<sup>th</sup> August. 2010.
- b) In case of professional and other Colleges, the enrolment forms along with the above requirements is required to be sent within one month from the date of actual commencement of first year classes as per the academic schedule.

- c) The enrolment number is required by the candidates to fill up their examination form. Hence it is necessary for the University to issue the registration cards to all the candidates as early as possible. The registration forms as per the dates indicated above may be sent to the University in one lot.
- d) The Principals are requested to adhere to the time limit indicated above. A late fee of Rs.100/- per month per student for every delayed month will be chargeable to the College for sending the enrolment forms after the due dates as indicated above.
- e) The Principals are also requested to send the complete list with details in one bunch and not in piece meal.
- f) The enrolment forms of student admitted late may be sent to the University in the second lot within 15 days from the closing date of First Year admission for which no late fee will be charged.
- g) The College will have to take responsibility for filling the correct information of the students especially with regard to the correctness of the name indicated. Copy of std.XII mark sheet to be enclosed.
- h) Kindly ensure that the name indicated in the Registration form is in conformity with the list of students submitted as given above.

The co-operation of all Principals/Deans of affiliated colleges is solicited to enable the University to complete the registration formalities at the earliest.

Procedure for issue of Provisional Eligibility Certificate, Confirmation of Provisional Eligibility Certificate and issue of Eligibility Certificate.

Attention of the Heads of the University Departments and Principals of affiliated Colleges is invited on the following:

- In respect of those students who are from other University or other than Goa Board of Higher Secondary Education, submission of Eligibility Certificate / Provisional Eligibility Certificate issued by the Goa University should be necessary at the time of admission of such
- University will issue Eligibility Certificates to those students who (ii) submit all the required documents at the initial stage viz (a) Copy of Marksheet (b) Copy of Passing certificate / Degree Certificate (c) Original Migration Certificate along with filled in application form and payment of fees of Rs. 350/-.
- Those students who are unable to submit all the required documents (iii) will be issued on scrutiny Provisional Eligibility Certificates provided the documents viz Copy of Marksheet (Internet copy attested by the School is also accepted) along with the filled in application form and payment of fees of Rs. 350/-.

Colleges/ University Teaching Departments are informed to forward the cases of students under category (iii) above for confirmation of eligibility on or before 30th November of the academic year on compliance of all other conditions stated earlier in the Provisional Eligibility Certificate along with the following documents

1. Original Migration Certificate

2. Copy of Marksheet/s, Passing Certificate/ Degree Certificate (Duly certified by the Principal/Head of the Department)

Further, Colleges/Institutions/University Departments are also informed to submit the list of students admitted on the basis of Eligibility Certificate/ Provisional Eligibility Certificate every year within one month from the last date of admission indicating (i) The Provisional Eligibility case Number (ii) date of issue (iii) The course for which admitted (iv) Nationality of the students.
